Approval of March 5, 2020 Executive Board Minutes: The minutes were accepted as printed.

#### Committee Reports:

**Community Service**: Jane Staton could not participate today, and Janet Leistner explained that Jane is continuing to collect members' volunteer service points to be submitted later to IRTA.

**Membership:** Darlene Brockriede announced that membership information was mailed to new retirees and only three were returned with insufficient addresses.

**Program/Luncheon:** Jan Craig reported that Dona Bone from the Evansville Wartime Museum will be our speaker for the October 8 luncheon meeting. Golden Corral will be able to provide whatever style meal we request from box lunches to buffet. Jan stated that she has received some member pictures for the Veterans slideshow and Walt Lewis's photo of himself in Egypt in 1985 was the first one submitted.

Publications: Diana Luck suggested a newsletter be sent to the membership after the ERTA Board decides about the October meeting. A Board meeting will be held in September to determine whether to meet in person or virtually in a Zoom meeting based upon the Covid-19 status. Diana was thanked for the awesome newsletter she publishes for the organization.

**Publicity:** Doris Beard discussed the ERTA Facebook page and encouraged Board members to like and join the page. Representatives of ERTA could appear on various local talk shows such as Midday with Mike and ABC 25 Local Lifestyles with Ange Humphrey.

Scholarships: Diane Meier and Donna Schmidt reported that due to the EVSC schools closing scholarship checks will not be mailed out until next spring. The scholarship amount available is about \$20,000.

IRTA Liaison/Legislative: Diane reported the Legislative Committee met on June 30, 2020. She shared Indiana state funds will be 1.4 billion less than projected. It was discussed whether state taxes will need to be raised to make up for the shortfall. This will again affect the approval of a 13<sup>th</sup> check or the slim chance of ever receiving a COLA. She shared that there are some retirees in the state suggesting on the internet or social media platforms to give current teachers

**Historian:** Darla Olberding was unable to attend today's meeting. Janet Leistner informed the Board that the ERTA filing cabinet was located, but it was locked with no key. She will attempt at a future date to have it opened by a locksmith.

#### Information Items:

- 1. Janet Leistner shared a letter she drafted to send to Dr. Smith and the EVSC School Board from our organization offering our support for all their endeavors during these Covid-19 challenges. The ERTA Board approved the sending of the letter and thanked her for her leadership and efforts.
- 2. Janet informed the Board that teacher candy baskets have been put on hold due to the uncertainty of the start of school. An attempt to distribute them closer to Christmas will be scheduled.
- 3. Proposed fundraising ideas will be welcome due to the cancellation of Frog Follies this August.
- 4. Teacher Locker is gearing up for the start of the school year according to Janet. Four teachers are allowed in at a time with two volunteers assisting them. Let Janet know if you or anyone you know might be interested in volunteering, and she will let Jeff Berger know. Doris Beard suggested that the Board donate \$100 to Teacher Locker with the table decoration money not used for our cancelled August meeting. A motion was made and seconded. The motion was approved. Lino will mail the check.
- 5. Installation of officers will take place during the October meeting.
- 6. Due to the cancellation of the May and August meetings, various ideas were discussed on how to stay in touch. Doris Beard suggested meeting at a park like Wesselmans to socialize. Of course, we would wear masks and social distance six feet apart in our lawn chairs.

#### Message from Diane Meier, IRTA Liaison/Legislative



The IRTA Legislative Committee met virtually via Zoom on November 10, 2020.

Steve Beebe, IRTA lobbyist announced that both the House and the Senate will maintain a Republican super majority at 71-29 and 39-11 respectively. The results of Covid-19 will make it difficult to contact legislators. The House is moving to the Government Building for this session. The Senate is spreading into their gallery. Beebe plans to go to the Statehouse every day but is not sure about the restrictions because testimony in Committee meetings will be limited to video shown from "side rooms." For that reason alone, it will be even more important for IRTA members to continue to contact their legislators using whatever method works.

Due in part to the pandemic, state revenues are down, and it could take us 2-3 years to see them return to normal. The Legislature will be looking for revenue and for ways to cut budget items. We will have to watch to see that the Pension Stabilization Fund is protected. However, the SRA account created in 2018 has about \$60m in it and is expected to get another \$30m. This is enough to cover a two-year 13th check including a \$50.00 enhancement. It is Beebe's opinion that we can ask for the "13th check" and an extra \$50 on it because there is enough in that account to cover the cost.

We ask that you contact your Legislature, especially if you know him/her to remind them of the following:

- a. The money is already in the SRA (Supplemental Reserve Account.)
- b. This is dedicated money that is not supposed to be used for any other purpose.

If you do not know your legislators, go to <u>http://iga.in.gov/legislative/find-legislators/</u> When you enter your address, it will tell you the legislators who represent your district. If we do not want to lose the money in the SRA account, we need to make these contacts.

The Legislative Committee's goals are to protect the PSF (Pension Stabilization Fund) and move ahead with the "13<sup>th</sup> check," including a \$50.00 enhancement.
