As stated in the following Board minutes, there will not be a 13th check this year. A 1% COLA for retired teachers, effective January 1, 2022, is in the 21/22 Indiana Budget. For most retirees that is less than we received with the 13th check. She also reported that the Indiana Legislature appropriated \$600 million to buy down debt in the Pre-96 Fund, and the Legislature fully funded the Pension Stabilization Fund.

Evansville Retired Teachers Association Executive Board Meeting May 6, 2021

<u>Call to Order</u>: President Janet Leistner called the in-person and Zoom meeting to order at 1:05 p.m. at Embrace Church and welcomed everyone. In addition to the president, those attending in person were Lynn Arteberry, Darlene Brockriede, Fred Bullinger, Jan Craig, Judy Isaac, Donna Lutz, Diane Meier, Don Mosbey, Sandra Schmidt, and Lino Wiseman. Walt Lewis and Diana Luck were on Zoom. Janet noted that this is the final meeting of our year.

<u>Approval of Minutes from March 4, 2021</u>: The first sentence of the Membership Committee report that said Darlene reported sending 293 newsletters was corrected to read only that 293 newsletters had been sent since Darlene had not sent them. The minutes were approved as clarified.

Officer Reports:

<u>Treasurer</u>: Lino Wiseman reported that he had sent the financial report to board members several days before today's meeting. The report will be filed for audit.

Lino said that he believes all members should be aware of the following information: There can be no more than \$2,000 in checking at the end of our year (end of June). Anyone who makes a purchase for the association cannot be reimbursed for sales tax unless a form has been completed. Fifty cents per paid membership goes to UE and to USI at the end of May. Ten dollars go to the scholarship fund for each deceased member. The Hensley is set to expire this year.

Lino said the checks sent for membership dues can be deposited in the ERTA account after June 30, 2021.

<u>President-elect</u>: Jan Craig said she had awarded a gift card to each of the following members: Karen Bippus, Beth Motley, and Scott Riley for March.

With plans to have the luncheon on August 12, 2021, Jan reported that she had contacted Golden Corral, Heavenly Ham, and Great Harvest about providing box lunches. She distributed menu selections for each of the three. The president wondered if \$12 was too much to charge and if the price should be lowered to \$10. After some discussion by the Board, Diane Meier made a motion to select Golden Corral and charge \$10 for the box lunch. Sandra Schmidt seconded. The motion passed.

Jan announced that she is currently contacting speakers and/or entertainment for the 2021/2022 ERTA meetings. The slate of officers listed in the May newsletter will be sworn in at the August meeting.

<u>Presentation</u>: Suzanne Williams, who retired as secretary at Embrace Church, was presented with flowers and a gift card.

<u>Committee</u> <u>Reports</u>:

<u>Community Service</u>: Janet announced that the number of volunteer hours for this past year numbered about 2,300. She asked that we keep track of our hours.

<u>Fellowship/Necrology</u>: Donna Lutz said that a sympathy card has been sent to Jim Sharp due to the loss of his wife.

<u>Reservations</u>: Janet announced that the same reservation form will be used this year and will be sent out in July.

Special Projects: Janet reported that Jim Sharp will chair the committee for Frog Follies this year.

<u>Scholarship</u>: Diane Meier announced that she had mailed checks to four educators at Cedar Hall who are recipients of the Hensley.
