Message from Diane Meier, IRTA Liaison

The Legislative Committee met on October 5, 2022. Here are some key points from that meeting:

Steve Beebe, IRTA lobbyist since 2013, reported on significant events that have happened since the end of the General Assembly last spring. He met with Senator Ryan Mishler, who chairs the Senate Appropriations Committee, on September 1. Sen. Mishler indicated he was not opposed to either a COLA or a "13th check" (stipend) as long as neither was funded by the General Fund. Senator Mishler is adamant that no money be taken from the General Fund.

Steve Russo, from INPRS (Indiana Public Retirement System), indicated in a late September meeting with Beebe present that the Supplemental Reserve Account (SRA) could pay the current "13th check" (stipend) amount for each of the next two years of the new budget.

Very recently, the teacher retirement fund received \$2.5B from the state surplus dollars left after the state budget concluded their fiscal year. This results in the unfunded liability being reduced to \$8.8B, which Sen. Mishler is wanting to be paid off by 2030, if not sooner.

The House Ways and Means Com. is now chaired by Rep. Jeff Thompson, a former teacher. He will be asked to recommend a House member to carry our IRTA bill.

The Legislative Committee recommends, and the IRTA Executive Board concurred, we should support a bill that would enact a "13th check" (stipend) in its current form (\$450.00) for each of the next two years.

As the time for the Legislative Session nears, we will be sending out more information as to how our members can impact the Legislation. As members, they should contact their respective Senators and Representatives. It is very important to be polite and positive with a "thank you" for the large contribution to the pension fund right up front. Postcards, letters, phone calls, and emails were all discussed as to our method of speaking to our legislators. Steve Beebe believes that emails are the most effective.

Executive Board Meeting
October 6, 2022

<u>Call to Order</u>: President Jan Craig called the meeting to order at 1:07 p.m. at Embrace Church and welcomed everyone. In addition to the president, the following were in attendance: Lynn Arteberry, Karen Bippus, Fred Bullinger, Judy Isaac, Janet Leistner, Donna Lutz, Diane Meier, Darla Olberding, David Pfettscher, Donna Schmidt, and Sandra Schmidt.

<u>Approval of Minutes from August 4, 2022</u>: Darla Olberding noted that the Fellowship/Necrology Committee was listed as Necrology only. Darla made a motion for the minutes to be corrected to read Fellowship/Necrology. Judy Isaac seconded the motion. The motion passed.

Officer Reports:

Treasurer: Lynn Arteberry gave the following financial report as of October 4, 2022:

Account Balance: \$2,989.70 Savings: \$240.90 Scholarship: \$13,930.24 Total Assets: \$17,160.84

Lynn then reported on several forms that she had filed.

Form NP-20 was filed with IN Department of Revenue to keep our nonprofit status.

Form 8822-B was filed with the IRS Department of Treasury for a Change of Address of the Responsible Party. Lino filed this form in June of 2021. Nothing was heard from the IRS until July of 2022. The IRS had changed the address to Lynn's address but left Lino's name. A new 8822-B form had to be sent to correct the error.

From 990-N was filed with the IRS so ERTA could remain tax exempt.

Lynn then reported on insurance coverage for the normal operating budget and the Hensley Scholarship. The first policy was written in 1989 by Schultheis Insurance for \$136 for three years of coverage. The underwriter was Cincinnati Insurance. Lynn reported that she learned this summer that Cincinnati no longer carried this product. As a result, she contacted Schultheis for a similar policy. The company quoted her a price of \$518 a year for bonding only

and suggested adding a general liability policy to cover the ERTA Board at a cost of \$575. The total annual premium would be \$1,093.

It was recommended that Lynn contact Shepherd Insurance, a company that writes for nonprofit organizations. She was given a quote of \$147 a year for coverage for \$5,000 for the treasurer only. The agent didn't see the need for the ERTA Board to be covered. The policy is underwritten by Liberty Mutual.

Darla made a motion to go with Shepherd Insurance for \$147. David Pfettscher seconded the motion. The motion passed.

Past President: Janet Leistner gave the following reports:

There are currently 298 on the list of members which includes new retirees. Seventy-four have not yet renewed. Janet said that she would send out an updated list in December.

Special Project funds in the amount of \$1,317.28 were received from Frog Follies. Janet made a motion to donate \$1,317.28 to the United Methodist Youth Home. David Pfettscher seconded. The motion passed.

Applications for United Way Grants are currently being read.

<u>President</u>: Jan reported that Janet will help with membership until a chair for the Membership Committee can be found. Jan then addressed various luncheon issues such as speeding up lunch service, returning to self-service as well as moving to the Sanctuary for the program and announcements.

Janet reported 89 reservations at this time.

Committee Reports:

<u>Community Service and Volunteer Hours</u>: Jan reminded members to keep track of their volunteer hours.

<u>Fellowship Necrology</u>: Donna Lutz reported sending a card to President-elect Doris Beard. Janet asked that a card be sent to Carol and John Koehler and that a sympathy card be sent to John and Nancy Roberts.

<u>Program/Luncheon</u>: Doris Beard reported by phone. She outlined next week's program celebrating ERTA's 60th Anniversary. Darla Olberding will begin the program with a presentation on the highlights of the last 60 years. A number of other past presidents will be honored and asked to share.

Jan added that Mayor Winnecke will read a Proclamation celebrating our 60th Anniversary. She said that ERTA is the third largest in Indiana.

<u>Scholarships</u>: Diane Meier spoke about a Hensley recipient who had been awarded \$1,000 but would like to attend the National Art Education Association in San Antonio that was not on the schedule earlier. The committee is recommending that \$1,661.00 be awarded to Heather Swade. Diane said that she will contact those on the original list to see if there are any other changes.

IRTA <u>Liaison/Indiana</u> <u>Legislature</u>: Diane spoke about various financial issues in Indiana concerning educators who must ask year-by-year for money. She said that the Senator who chairs the Appropriation Committee is not opposed to a COLA or a 13th Check.

Information Items:

Jan announced that Veterans will be honored at the luncheon since we don't meet in November.

Old Business:

IRTA Reconnect Workshop: Jan gave a short summary of the workshop that was held on Thursday, September 21, 2022, at the Gasthoff Restaurant in Montgomery, IN.

New Business:

Otters Baseball: Jan received a message from Nolan Vandergraff asking if ERTA wanted to reserve a tent next year for May or June. The consensus was that we do want to reserve a tent, probably in May.

Next ERTA Executive Board Meeting: Thursday at 1:00 p.m. on December 1, 2022

Adjournment: The meeting was adjourned at 2:48 p.m.

<u>Announcement</u>: Jan announced that Mayor Lloyd Winnecke would be arriving later to present the City of Evansville Proclamation to the Evansville Retired Teachers Association in recognition of ERTA's 60th Anniversary.

Approval of Luncheon Meeting Minutes for August 11, 2022: The minutes were accepted as written.

<u>Blessing/Prayer</u>: Jan read a blessing, and Steve Fritz read a devotional and prayed.

<u>Recognitions</u>: Jan asked those who served in the Armed Forces to stand and be recognized. Each one received a card and a patriotic-themed Chap Stick.

All ERTA Past Presidents were asked to stand and be recognized as well.

<u>Lunch</u>: Veterans, past presidents, and their spouses went through the lunch line first. Members were called by random years. Doris thanked Golden Corral.

<u>Drawings for Gift Certificates</u>: Jack Weatherholt drew the first number; Walt Lewis drew the second; and Jack Weatherholt drew the third.

Doris asked past presidents to report to the Sanctuary. Members reported shortly after.

<u>Program</u>: Past President Darla Olberding gave a twenty-minute presentation documenting the history of the Evansville Retired Teachers Association.

The first meeting was held in 1952; however, at the end of five years, no would take leadership. The organization resurfaced in 1962 and was known as the Southwest Indiana Division of Retired Teachers.

As of today, there have been 56 presidents, four who have served two terms.

In 1972 the organization affiliated with NEA.

Teachers began acting as tour guides for the Visitors Bureau and later became involved in Frog Follies, sponsored by the Visitors Bureau, in 1980.

In 1995 ERTA had a new newsletter, School's Out Gazette.

In 1999 ERTA became affiliated with IRTA.

Around 2003 the Hensley Scholarship was established with an approximate donation of \$130,000 from an educator who had passed away. The money was for teacher scholarships.

In 2004 archives were established at Willard Library.

In 2011 Past President Pat Eager started the Christmas collection at the December luncheon. More than \$10,000 has been collected.

Welcome Back Candy Baskets were distributed to all EVSC Schools in August of 2013 for the first time to welcome teachers back to the classroom.

In 2019 ERTA became one of the sponsors of Teacher Locker.

ERTA has given approximately \$140,000 in scholarships over the 60 years.

Words from Past Presidents:

Jan read a message from Bob Kraft. Then Diane Meier, Jerry Noland, Jack Weatherholt, Mike Madriaga, Earl Pfettscher, Sylvia Blice, and Pat Eager spoke briefly. Other past presidents in attendance were Terry Becker, Steve Fritz, Andy Guarino, Janet Leistner, Walt Lewis, Bob Surheinrich, Gene VanStone, and Brenda Weber.

<u>Introduction of Mayor Lloyd Winnecke</u>: Jan introduced Mayor Winnecke who read the City of Evansville's Proclamation celebrating October 13, 2022, as the Evansville Retired Teachers Association's 60th Anniversary Day.

Mayor Winnecke then spoke about a large number of improvements, some already completed, some currently in process, and some upcoming, in Evansville.

A Certificate of Appreciation was given to the mayor and to each past president. Darla Olberding received a \$25 gift card.

Adjournment: The meeting was adjourned at 2:20 p.m.
