## Message from Diane Meier, IRTA Liaison/Indiana Legislature, Legislative News

We've secured one more year of the "13th Check" – this is meaningful progress! A key point of clarity: the funding for the "13th Check" comes from the Supplemental Reserve Account, which is supported by the Hoosier Lottery and local corporation surcharges – not from the state's general fund. However, budgetary cuts and limitations were across the board, as fiscal pressures continue to increase. Thus, the check with be 5% less than previous checks. The 13<sup>th</sup> check will be included in the September check

We are not locked into a 5% reduction for upcoming years.

We remain steadfast in our primary goal: securing permanent pension enhancements, whether through an annual "13th Check" or a COLA, depending on retirement date.

## **IRTA General Assembly News:**

The General Assembly met on June 11 in Indianapolis. Gene Van Stone and I were the only delegates from ERTA. I would encourage members to attend next June. It is an informative day.

One item of New Business was the raising of IRTA dues; they had not been raised in 20 years. Dues are now \$42.00 a year. If you do not belong to IRTA, I would encourage you to belong. This is the organization that works to bring you the 13<sup>th</sup> check. You can pay those dues several ways:

Recurring Deductions:

\$42 yearly deducted from your pension – this is the easiest way.

\$42 yearly deducted from a credit card.

\$42.00 one year paid by credit card.

If interested, there are also life memberships:

62 and under \$1000

63 - 75 \$750

76+ \$500

Associate member dues were raised to \$20 yearly. Those can also be deducted yearly from a credit card.

**President** Victor Doty called the meeting to order. The minutes from March 6 were approved.

#### **Committee reports**

- Community service and volunteer hours, Jane Staton: Members should fill out their volunteer hours in December. The hours will be reported in the newsletter.
- Fellowship/Necrology, Janet Leistner: Linda Hawkins died.
- Membership, Lynn Arteberry (Janet Leistner): Lynn reminded members to give our addresses in case a card needs to be sent.
- Program/luncheon (for May). 85 people reserved for luncheon at SICTC. The Evansville Civic Theater will present a program. A representative from CASA (court-appointed special advocate) will present an explanation of their program and need for volunteers. Donation for \$1000 will be awarded to the Methodist Youth Home at the luncheon.
- Publications/Publicity, Diana Luck: Newsletter received. We need a new leader for publicity as Frankye Calloway resigned.
- Registration, Judy Issac: Judy will get workers to sign in people to the luncheon and to take payment.
- Special projects. Doris Beard and Lynn Arteberry: \$1000 approved for contribution to the United Methodist Youth Home. \$300 remains a continuing donation for students attending USI and UE.
- IRTA liaison/Indiana legislature, Diane Meier: Request for 13th check approved for \$427.50. The amount was reduced by 5% as were all other requests. Teachers will be getting the check in October. The bill passed the House and Senate. IRTA asked for multi-year check approval, but that request was denied. - Budget discussion led by Lynn Arteberry. She submitted the ERTA draft fiscal year budget for 2025-2026. There is no need for a rise in dues as we received a \$1600 saving by moving to SICTC. We brought in \$3,300 from dues. We earned \$2000 from Frog follies. Fifteen dollars will remain the charge for luncheons. Scholarship charges will be moved to the general fund. There was discussion on changing the gift card amount for those presenting programs, but no decision was made. Lynn also submitted the May ERTA finance report.
- Discussion of giving \$100 to SICTC for helping us acquire and use Assembly Hall but did not want to pay custodian who is an employee (Note: Original proposal was to give to SICTC to use for faculty or students not to pay custodian will revisit in August)
