**Meditation:** Chaplain Ed Rusk read “The Mighty Oak Was a Little Nut That Stood Its Ground.” He read Proverbs 12:3 and prayed.

**Approval of August Minutes:** The August 1, 2013 Executive Board Minutes were approved as printed.

#### **Officer Report:**

**Treasurer:** Lino Wiseman distributed a copy of the 2013/2014 Budget. He reported that \$1,664.25 had been received from Frog Follies and deposited into Special Projects.

#### **Committee Reports:**

**Community Service:** IRTA Past President Bob Kraft spoke about the importance of members turning in volunteer hours in December.

**Fellowship/Necrology:** Linda Hape reported that three members have passed away since the last newsletter. Linda Staley reported that two get well cards have been sent to members.

**Membership:** Darlene Brockriede reminded the Executive Board that those who have not paid dues by the end of October will be removed from the membership list. The Executive Board agreed that the new list should be mailed to ensure that each member receives a copy.

**Publications:** Jerry Noland announced that Scott Riley will take over the web page.

**Reservations:** Diana Luck reported 162 reservations have been received for the October luncheon.

**Scholarship:** Mike Madriaga said that the process to determine the recipients of the Hensley Scholarships will begin in two months.

**IRTA/ Legislative:** Diane Meier distributed several copies of a brochure prepared by IRTA that explains why retired teachers need and deserve a COLA. The brochure will be given to members of the Indiana State Legislature. Suzanne Crouch has agreed to author the bill and introduce it in the House. Bob Kraft suggested that members attend the local “Meet Your Legislators.”

Bob Suhrheinrich introduced Bill Schirmer, President and CEO of the ETFCU, who came into the meeting to welcome us.

**Historian:** Darla Olberding reported that she has been saving newspaper articles that pertain to members.

**Frog Follies:** Bob said that ERTA volunteers usually work two to three hours at the event. Money that the association earns allows us to do special projects.

**Publicity:** Nancy Noland reported on the State Public Relations Committee Meeting held on August 15, 2013, in Indianapolis. Also, Nancy showed the Executive Board a bookmark prepared by IRTA Southeast. She suggested that ERTA prepare a similar bookmark for distribution.

**Policies and Procedures Update:** Carol Koehler went over the current policies and procedures that have been reviewed by a committee. Changes made in the future will require action by the Executive Board, not by the general membership.

**Business Items:**

1. Dick Sprinkle explained why he is stepping down from the office of president-elect. Bob suggested that Dick complete the term of Director Garland Aramowicz, who had resigned. Darla made a motion to accept Dick Sprinkle as the new director. Diane Meier seconded. The motion passed.

2. Bob suggested that Andy Guarino complete the term of President-Elect Dick Sprinkle. Darla Olberding made a motion to accept Andy Guarino as the new president-elect. Pat Eager seconded. The motion passed.

3. The Executive Board agreed to have the Dream Center as the project for Christmas. Darla made a motion to collect money at the luncheon in December for the Dream Center to use for educational needs. LaVonne Miller seconded. The motion passed.

**Announcements:**

1. Newly-retired teachers will continue to be notified about future meetings.

2. At the IRTA Fall Leadership Workshop held on September 19, 2013, discussion centered on the Affordable Care Act, a cost of living adjustment (COLA), and the Association Member Benefits Advisors (AMBA).

3. President and CEO of the YMCA Derrick Stewart will speak at the luncheon on October 10, 2013.

4. The Executive Board will meet on December 5, 2013.
