

**Executive Board Meeting** 

May 7, 2015

<u>Call to Order</u>: President Andy Guarino called the meeting to order at 1:06 p.m. at the Phipps Center. In addition to the president, the following were in attendance: Brenda Beeler, Darlene Brockriede, Linda Hape, Diana Luck, Diane Meier, LaVonne Miller, Fred Naab, Jerry Noland, Nancy Noland, Ed Rusk, Sandra Schmidt, Linda Staley, Brenda Weber, Tom Wiggers, and Lino Wiseman.

<u>Meditation</u>: Chaplain Ed Rusk read "If at First You Don't Succeed, Try Reading the Instructions." He then read Proverbs 4:13 and prayed.

Approval of March 9, 2015 Minutes: The minutes were approved as printed.

Officer Reports:

<u>Treasurer</u>: Lino Wiseman distributed the financial report. The Rescue Mission returned our check for \$1,103 for the March luncheon, but Lino felt we owed something. (See New Business.) There were no questions about the financial report.

<u>President</u>: Andy gave the following reports: He has not received any calls concerning "A Hand Up," the IRT Foundation program. Nancy and Jerry Noland and Diane Meier attended Lobby Day in Indianapolis on April 8, 2015. The recipient of our scholarship at UE is education major Alie Duff from Evansville.

### Committee Reports:

Auditing and Budget: The books will be audited in July.

<u>Community</u> <u>Service</u>: Andy asked members to continue volunteering.

<u>Fellowship/Necrology</u>: Linda Hape reported that no one has passed away since the last newsletter. Linda Staley said that she has sent three get well cards. Ed will read the Necrology Report at the May meeting.

<u>Membership</u>: Brenda Weber informed the board that she had e-mailed 62 educators who plan to retire. Darlene Brockriede will send a letter to those who have not responded.

<u>Reservations</u>: Diana Luck announced 145 reservations for next week's luncheon.

<u>Special Project</u>: Thanks to the Nolands who contacted Mayor Winnecke's office requesting a proclamation in support of National Teacher Appreciation Day. Mayor Winnecke read the proclamation at the EVSC Board of School Trustees meeting on May 4, 2015.

<u>IRTA</u> <u>Legislative</u>: Diane reported the vote to give a stipend to retired teachers was a last minute, last day decision. The stipend is for one year.

Historian: Andy asked if we needed to keep this committee. No decision was made.

<u>Publicity</u>: Area 9 State Public Relations Representative Nancy Noland attended a meeting of the State Public Relations Committee in Indianapolis on April 9, 2015. The ERTA submissions received the following recognitions: Outstanding Newsletter, Outstanding Press Releases, and Outstanding Website with the stipulation that a contact be added to the homepage. (Andy said it's already there; a person has to click on it.) Awards will be presented on June 17, 2015, at the IRTA Representative Assembly in Indianapolis.

Frog Follies: Volunteers are needed. The event will take place August 28 - 30, 2015.

Information on the Side Table: Author Linda Deitchman will be at the table to promote her book.

# Unfinished Business:

<u>Approval of funds for Youth First</u>: LaVonne Miller made a motion to donate \$1,000 to Youth First, and Linda Staley seconded. The motion passed unanimously.

<u>Approval of funds for Welcome Back Baskets</u>: Diane made a motion to allocate \$300 for the baskets, and Tom seconded. The motion passed unanimously.

<u>Approval of revised ERTA Bylaws</u>: Members will vote on the revised bylaws at the luncheon. Brenda said that the two amendments will be read.


