Other Important News for Our Members:

- David Pfettscher reported the luncheon information for October 9, 2014. We had 148 total attendees, 140 paid, 3 new teachers, and 5 guests. We also had 18 no-shows and 5 cancellations. Please let us know when you are not able to attend if you have made a reservation.
- Please remember our collection for ARC of Evansville's Christmas gift. Please give as much as you can.
- I attended the USI Scholarship Donor Banquet on October 29, 2014. Our representative scholars were Miss Megan Hipp and Taylor Ellis.

COLA Bill (Cost of Living Adjustment):

The COLA bill could be a hard sell this legislative session because the chairman of the Senate Appropriations Committee, Sen. Luke Kenley, and others are not proponents of the bill at this point.

The last time a COLA was given for teachers was in 2009, and retired teachers were given the 13th check each year since 2009.

According to an INPRS presentation to the Pension Oversight Management Committee this interim, the cost of a 1% COLA is \$88.12 million for members of the pre-1996 Teachers Retirement Fund and \$6.43 million for members of the 1996 Teachers Retirement Fund. The cost of a 13th check is \$20.3 million for members of the pre-1996 Teachers Retirement Fund and \$5 million for members of the 1996 Teachers Retirement Fund. Please note that the TRF pre-1996 retirement fund is a pay-as-you- go pension plan and subsequently any time a COLA or 13th check is given, the state must pay for the benefits from the state general fund. The TRF 1996 retirement fund is actuarially funded, so typically the COLA or 13th check would be paid for as a part of the employer (aka school corporations) contribution rates. So you can see why the state is hesitating for a change.

However, with the \$22 million (\$22 per hour) donated in volunteer hours over the last six years, which equates to over a million hours of community service, the gap becomes smaller. Also, the amount of money pumped into the community economy by our retired teachers is very consistent.

So, even though this will be a tough sell, it is a budget session, and if we lobby our legislators assertively, it could be possible. I will have a sample letter to send out to all legislators that I will make available in the March newsletter. You can use it or write on your own. This may be our last chance at a COLA for a while. We need to act quickly and precisely. Thank you! Andy Guarino, ERTA President

Executive Board Meeting

October 2, 2014

<u>Call to Order</u>: President Andy Guarino called the meeting to order at 1:03 p.m. at the Phipps Center. In addition to the president, the following were in attendance: Brenda Beeler, Darlene Brockriede, Linda Hape, Diana Luck, Mike Madriaga, Diane Meier, LaVonne Miller, Fred Naab, Jerry Noland, Nancy Noland, Darla Olberding, Ed Rusk, Sandra Schmidt, Linda Staley, Brenda Weber, and Lino Wiseman.

<u>Meditation</u>: Chaplain Ed Rusk read "Sometimes We Are So Busy Adding Up Our Troubles That We Forget to Count Our Blessings." He then read Psalm 77:11,12 and prayed.

Approval of August 7, 2014 Executive Board Minutes: The minutes were approved as presented.

Officer Reports:

<u>Treasurer</u>: Lino Wiseman distributed the financial report. He reported that ERTA received \$1,702.31 from Frog Follies. Expenses for food and stamps totaled \$254.76. There is a balance of \$1,506.77 in the Special Projects account.

<u>Secretary</u>: Sandra Schmidt read a copy of the note of appreciation sent to Indiana State Superintendent of Schools Dr. Glenda Ritz, who spoke at the August luncheon.

Committee Reports:

<u>Community Service</u>: Andy reported that ERTA members have volunteered over one million hours over six years, which is equal to 22 million dollars.

<u>Fellowship/Necrology</u>: Linda Staley said that six get well cards have been sent since the August newsletter. Linda Hape added that seven retired teachers have passed away during the same time period.

<u>Membership</u>: Darlene Brockriede announced that 187 have paid their dues this year, but 140 who paid last year have not paid this year. Darla volunteered to send those without e-mail a reminder. Darlene added that there are 111 retirees this year.

<u>Nominating</u>: President-Elect Brenda Weber asked that the members of this committee plan to stay after the December Executive Board meeting for a few minutes to determine when the committee will meet.

<u>Publications/Newsletter</u>: To avoid paying for extra postage, the newsletter can be no longer than ten pages.

<u>Website</u>: Scott Riley has updated the information on the ERTA website.

<u>Reservations</u>: Diana Luck reported approximately 150 reservations for the October luncheon.

<u>Scholarship</u>: Mike Madriaga announced that teachers will be notified in December of the availability of the Hensley Scholarship. Notification is made through Marsha Jackson's office; the information will be in the <u>E-News</u>.

<u>IRTA Legislative</u>: Diane stated that if there is no COLA this year, it probably will never happen. The money is in the retirement fund, but the legislature controls it. Andy reported the cost of a COLA at 81.6 million, a stipend at 19.3 million. Jerry Noland said the lack of a COLA has cost each retired teacher about \$2,000.

<u>Publicity</u>: Nancy Noland informed the Executive Board that she will be working with Jack Schriber to obtain more publicity for ERTA.

General Information:

Information Table: Jerry and Nancy will be at the table to give information and encourage associate memberships.

IRTA Workshop: Discussion centered on the need for a COLA and the push to increase the number of associate members.

Unfinished Business:

<u>Christmas Project</u>: The ARC of Evansville is our Christmas project. Money collected at the December luncheon will be used to provide pre-k for disabled children.

New Business:

<u>Membership Survey</u>: Those in attendance received a copy of the questionnaire prepared by Brenda and Andy. Brenda asked for our thoughts. After some discussion, Darla made a motion to distribute the questionnaire at the luncheon with the addition of a place for members to comment. Linda Hape seconded the motion. The motion passed.

<u>Forming "A Hand Up" Committee</u>: The Executive Board decided that a local committee was not needed.

<u>Christmas Gift for the American Baptist East Custodian</u>: Lino stated that what ERTA pays the church is only for the use of the church; none of the payment goes to custodian Jason Miller for his help. As a result, the Executive Board decided on a one-time Christmas gift for Jason. Ed was asked to make a motion. The motion was to give Jason a \$100 gift card for his year's work. Diane seconded. The motion passed.
