\* Albion is a domestic and sexual violence agency with a mission to prevent domestic and sexual violence and empower victims through advocacy, education, support services and collaborative partnerships. Probably best known as a domestic violence shelter, Albion is the only agency in the area known as aRape Crisis Center. It is also the only agency in the immediate area with a primary prevention program for middle and high school youth. It serves three times as people in their non-residential Outreach program than in their shelter. Last year, they served 700+ adults and children in their shelter.\*

Your support will help to bring support, safety and some amount of joy to lives severely disrupted by abuse. Please be generous!

They will hopefully leave us with a fresh sense of hope and excitement about the upcoming holiday. Give them some applause and a compliment if you get the chance. I will be the guy over to one side with the goofy grin on my face, because I know how much fun they are having. Already halfway through their holiday season, they are creating rich memories that last a lifetime. It just doesn't get any better!

## **Executive Board Meeting**

October 6, 2016

<u>Call to Order</u>: President Tom Wiggers called the meeting to order at 1:02 p.m. at American Baptist East Church and welcomed everyone. In addition to the president, the following were in attendance: Terry Becker, Darlene Brockriede, Judy Issac, Diana Luck, Diane Meier, Don Mosbey, Fred Naab, Darla Olberding, David Pfettscher, Ed Rusk, Brenda Scheidler, Sandra Schmidt, Brenda Weber, and Lino Wiseman.

<u>Meditation</u>: Chaplain Ed Rusk read "A Drowning Man Does Not Complain about the Size of a Life Preserver." He then read Philippians 2:14 and prayed.

<u>Acceptance of Agenda</u>: Tom asked that today's agenda be accepted with flexibility. Diane Meier made a motion to accept today's agenda with flexibility. Don Mosbey seconded the motion. The motion passed.

Approval of August 4, 2016 Executive Board Minutes: The minutes were approved as printed.

# Officer Reports:

<u>Treasurer</u>: Lino distributed a financial report dated August 31, 2016. He said that 125 members have paid dues at this time. He also reported that the association has received a check for \$1,634.06 from Frog Follies. Of that total, \$295.20 was used to feed our workers, and the remaining amount of \$1,338.86 was put into the Special Projects account.

(Note: The account balance also includes \$18.32 that was returned after the purchase of candy for the Welcome Back Baskets.)

<u>President-Elect</u>: Terry Becker informed board members that he had received a notice from the Rescue Mission saying that the organization would no longer be able to offer catering. Several members suggested some restaurants as possible options for our remaining luncheons this year.

Indiana State School Superintendent Dr. Glenda Ritz will speak at next week's luncheon. Evansville Mayor Lloyd Winnecke will speak in the spring.

<u>President</u>: Tom explained that ERTA is in need of a logo. He said that Jon Siau will be working on this project.

#### Committee Reports:

<u>Auditing and Budget</u>: Darla Olberding reported that the books were audited and found to be in good order.

<u>Membership</u>: Since dues are to be paid by the end of October, Darlene Brockriede suggested contacting those who have not paid.

Publications: Diana Luck asked for a decision as to which items would not be included

In the next several issues of the newsletter. The membership form will no be included as well as the list of board members.

<u>Publicity</u>: Judy Isaac reported submitting an article to the local newspaper about ERTA's donation to Hangers. The check was awarded at an EVSC School Board Meeting.

Reservations: Diana Luck announced that there are 135 reservations for next week's luncheon.

<u>Scholarships</u>: Diane Meier said that information about the Hensley scholarships will be sent to EVSC in December. The information must be sent electronically because it cannot be put into teachers' mailboxes. Last year eight scholarships were awarded; only eight applied. Ten are available.

<u>IRTA</u> <u>Liaison/Legislative</u>: Diane reported that this year is our best chance for a COLA. The last COLA was in 2007. The stipend that we have been receiving in September is not automatic. In March there will be a push to contact members of the Indiana Legislature.

<u>Historian</u>: Darla Olberding asked if the board wanted to continue printing "ERTA Trivia" articles in the newsletter. The board wanted to continue.

Old Business: There was none.

New Business: There was none.

Announcement: The next ERTA Executive Board Meeting will be December 1, 2016.

Adjournment: Brenda Weber made a motion to adjourn. Judy Isaac seconded. The motion passed.

Upon her arrival, State Superintendent of Public Instruction Dr. Glenda Ritz was introduced and seated at the head table.



Words of Appreciation: Tom thanked Ed and Ruby Rusk and Don and Susan Mosbey for getting everything ready for our luncheon.

<u>Acknowledgements</u>: Tom acknowledged EVSC School Superintendent Dr. David Smith, who was seated with the membership. David Pfettscher and his group of volunteers who collected the money for today's luncheon were also acknowledged.

<u>Volunteer Hours</u>: Tom called our attention to the green papers on each table on which members could record their volunteer hours. He said that members could give the papers to Jan Kraft today, send her a text or email, call her, or mail the hours to her. The green papers will be available at the December luncheon as well.

Recognition of Veterans: Veterans were called to the front and asked to introduce themselves. Dr. Jack Humphrey, one of the veterans, led the Pledge of Allegiance.



<u>Meditation</u>: Chaplain Ed Rusk read "The Difference Between Ordinary and Extraordinary Is That Little Extra." He then read Ecclesiastes 9:10 and prayed.

Lunch: Those seated at the head table were dismissed for meal service followed by members.

<u>Program</u>: Tom introduced today's speaker, Dr. Glenda Ritz. She began by reporting that 191 schools with 108,000 students have been turned around at this point. Then, Dr. Ritz discussed her goals: having a fully funded pre-k, utilizing a computer test that adapts to each child's level, ensuring that high school students are prepared for a trade or college, recruiting quality teachers, and revisiting teacher evaluations that are currently linked to students' test scores. The program ended with a question and answer session.



Approval of August 11, 2016 Luncheon Minutes: The minutes were approved as printed.

Announcements:

- 1. Tom thanked Diana Lynn for the table decorations.
- 2. He also thanked the Rescue Mission for catering our lunch today and announced that the Mission is no longer in the catering business.
- 3. The next luncheon will be December 8, 2016.

Adjournment: The meeting was adjourned at 1:15 p.m.
