From Our President, Andy Guarino

My message this spring newsletter is to encourage all our members to write or email your state legislators during this current legislative session and to let you know how very important your involvement is needed during this vital budget year in regards to our "Cost Of Living Adjustment (COLA)."

The following information will assist you through the process when you write your letter to our legislators regarding the "Cost Of Living Adjustment (COLA)" or House Bill HB1464.

- 1. To find your legislators and Governor, go to the Web site "Indiana General Assembly Home," and at the bottom of the screen, click on the tab "Find Your Legislator," and put in your address. (This will show the address and/or email address.)
- 2. You can send a letter to any or all legislators by sending it to 200 W. Washington Street, Indianapolis, IN 46204, or email them at their email addresses.
- 3. Envelopes should be addressed as Honorable (first name, last name) and the greeting should be Dear Representative (last name) or Dear Senator (last name), or Dear Governor Pence.

Begin your email or letter by thanking the legislators for their past support for the "13th check." Then remind them that we have not had a "COLA" for six years and that our purchasing power, which would have been spent in local businesses, ultimately returning back to the state in the form of sales tax, has been diminished.

If possible, add in a personal scenario about yourself; such as, you have been retired since (year), and the amount of your pension does not even allow you to keep up with the cost of living. (Legislators take note of personal, heartfelt stories.)

Finally, mention the \$22 million (\$22 per hour) donated in volunteer hours over the last six years, equating to over a million hours of community service.

This could be our last opportunity for a "COLA" until the next budget cycle in two years; so, please, let's do everything we can now to make sure this session ends with a "COLA" in our hands.

Our legislative day at the State House is April 8, 2015, from 8-10 a.m. Evansville time. We need as many members as possible to attend.

The fourth ERTA luncheon of this school year will be held on Thursday, March 12, 2015, at the American Baptist East Church at 6300 Washington Avenue at 11:30 for socializing and lunch at 12 noon. The cost is \$10.

- Please reply to my e-mail by February 27 only if you plan to attend.
- Include your name and number of reservations.



<u>Meditation</u>: Chaplain Ed Rusk spoke briefly about the sudden passing of Phyllis Fitzgerald, the editor of our newsletter, and asked for a moment of silence in her memory. He then read a short piece concerning the farewell words Moody reportedly had spoken to his sons when he was on his deathbed: "If God be your partner, make your plans big." Ed concluded with the words of Philippians 4:13 and a prayer.

Approval of October 2, 2014 Minutes: The minutes were approved as printed.

Officer Reports:

<u>Treasurer</u>: Lino Wiseman had nothing to report other than saying that he is continuing to collect dues. He had distributed the financial report earlier.

<u>President-Elect</u>: Brenda Weber said the nominating committee will meet after today's meeting to determine a slate of candidates.

Committee Reports:

Community Service: Andy spoke about the importance of turning in all volunteer hours.

<u>Fellowship/Necrology</u>: Linda Staley reported sending one get well card and one sympathy card. Linda Hape added that she had sent two sympathy cards.

Membership: Darlene Brockriede said the membership roster was sent out on November 22, 2014. There are 434 members of which 105 do not have e-mail. Associate members number 28 and past presidents, 16. There is one honorary member. One hundred fourteen educators retired in 2014 and have free membership for one year. There will be some extra copies of the membership roster at the luncheon. Andy said that those who have e-mail will be encouraged to let ERTA know, so eventually we can go paperless.

<u>Publications</u>: Due to the passing of Phyllis Fitzgerald, Diana Luck volunteered to serve as editor of the newsletter for the reminder of the year.

Website: The website has been updated.

Reservations: Diana reported that reservations number 211 at this time.

<u>Scholarship</u>: Diane Meier announced that the application for the Hensley scholarship has gone out. The applications will be read in January.

<u>Christmas Project</u>: Money will be collected for Arc of Evansville. Cash or checks will be accepted. A basket to hold donations will be on each table.

<u>IRTA/Legislative</u>: Diane noted IRTA Executive Director Nancy Tolson's frustration with the election. The senate chair of ways and means has to allow the COLA bill to be read; that is unlikely to happen. Volunteer hours are very important as well as letters to our legislators that need to be written in the spring. When the fund was established, the expectation was that there would always be a COLA.

Information:

<u>State Grant Committee</u>: Immediate Past President Bob Suhrheinrich was asked to join a committee that would research grants currently awarded to active teachers. The plan is to start with the awarding of one grant of \$750 or \$1,000 per district; there are ten districts in Indiana. Bob said the process has yet to be determined.

Side Table Invitations:

Andy said the Tri-State Food Bank and the Red Cross of Evansville will possibly be in attendance at the luncheon; however, Ashley McReynolds of the Koch Family Children's Museum (cMoe) will attend.

Old Business:

Results of the ERTA Survey: The results were published in the December newsletter. Brenda Weber shared some of the comments from the survey. She added that the needs of our speakers will determine if we move to the sanctuary for the program.

<u>Christmas Gift for Jason Miller</u>: Ed will present a check to Jason Miller, the custodian at American Baptist East, who sets up everything needed for our luncheons. In October the board voted to give Jason a one-time gift of \$100.

New Business:

<u>Bylaws Committee Update</u>: The committee will meet again before presenting the updated document for membership approval in March or May.

<u>Draft of Legislative Letter</u> - <u>COLA</u>: Members may use the draft that will be printed in the next newsletter or write their own. Letters may be mailed or e-mailed.

<u>Door Prizes for the Christmas Luncheon</u>: Door prizes will be donated by ERTA Board members.

Gift to North Varsity Singers: A gift of \$100 will be given to the North High Varsity Singers for providing musical entertainment at our luncheon.

Announcements:

- 1. Andy attended the USI Donor Scholarship Luncheon.
- 2. Nancy Tolson and the new IRTA Executive Director will attend our May meeting.

Tom made a motion to give Nancy a parting gift. Brenda Beeler seconded. The motion passed.

Adjournment: With no further business, the meeting was adjourned.
