
### Derrick Stewart, CEO, YMCA Southwestern Indiana

### **Executive Board Meeting Minutes**

### August 1, 2013



President Bob Suhrheinrich called the meeting to order at 1:00 p.m. at the Phipps Center. The following were in attendance: Brenda Beeler, Darlene Brockreide, Pat Eager, Linda Hape, Diana Luck, Mike Madriaga, Diane Meier, LaVonne Miller, Fred Naab, Nancy Noland, Jerry Noland, Darla Olberding, Charlotte Reitz, Ed Rusk, Sandra Schmidt, Linda Staley, Bob Suhrheinrich, Gene VanStone, and Lino Wiseman.

Chaplain Ed Rusk read "Happiness Is a Perfume You Cannot Pour on Others without Getting a Few Drops on Yourself." He then read Matthew 5:6 and prayed.

The May 2, 2013 Minutes were approved as printed.

### Officer <u>Reports</u>:

**Treasurer:** Lino Wiseman distributed the 2012/2013 Year-end Report and the Proposed 2014 Budget. He informed the Board that the 2012/2013 Federal Tax Form as well as the 2012/2013 Indiana Department of Revenue Tax Form had been submitted. Also, to keep the checking account balance under \$2,000, he transferred \$1,226.00 to the Hensley Scholarship Fund. The current checking account balance is \$1,999.20.

Lino then went over the year-end report saying the items highlighted in green were the positives; the items highlighted in tan were the negatives. He noted that our insurance bond is due this year, the amount being \$270.

Darla Olberding asked if the proposed budget for postage and office supplies is sufficient since we no longer mail the number of newsletters required for bulk mailing. Bob reported that it cost \$69 to mail the 150 August newsletters. Almost half were sent to newly retired teachers. Diana Luck said that the newly retired teachers are used to e-mail and will elect to receive the newsletter that way. Diane Meier made a motion to approve the 2012/2013 Year-end Report. Sandra Schmidt seconded. The motion passed unanimously. Diane then made a motion to approve the 2014 Budget. Sandra seconded. That motion also passed unanimously.

**President:** Bob said EVSC Superintendent Dr. David Smith will speak at next week's luncheon.

### **Committee Reports:**

Auditing and Budget: Darla announced that the treasurer's books were audited and found to be in good order.

**<u>Community</u>** Service: Bob emphasized the importance of reporting our volunteer hours to Jan Kraft.

<u>Fellowship/Necrology</u>: Necrology Chair Linda Hape reported that five members have passed away since the newsletter was sent.

<u>Membership</u>: Darlene Brockriede said that a list she received from Debbie DeBaillie listed 73 newly retired teachers.

<u>Nominating</u>: Directors Fred Naab and Charlotte Reitz will meet with President-Elect Richard Sprinkle in January to prepare a slate of officers.

**Publications:** Jerry Noland, reporting on the website, said that there will be a \$200 charge unless we get another host. He said that he would like someone to work with him this year, so that person can take over next year.

**<u>Reservations</u>**: Diana reported 186 reservations for the luncheon. That number includes 30 newly retired teachers.

**Scholarship:** Mike Madriaga announced that last year's recipients of the Hensley, with one exception, have completed their work. He made a motion on behalf of the committee for \$10,000 to be made available for the Hensley Scholarship in 2013/2014. The motion unanimously passed.

**Special Project:** Gene VanStone asked the Board to think about some ideas for humanitarian projects. Money from Frog Follies supports the special projects. The Christmas Project is supported with contributions given at the luncheon in December.

**IRTA/Legislative:** Diane said Governor Pence has decided that excess funds will not be going into the Pension Stabilization Fund but into prison construction. She reminded us that the extra money in the September check is a stipend, not a 13<sup>th</sup> check. Diane said the most important steps that ERTA members can take are joining IRTA and turning in our volunteer hours. IRTA will be lobbying with the state legislature for a COLA and a stipend. Half of the retired teachers belong to IRTA.

**Publicity:** Nancy Noland announced a State Publicity Committee Meeting will be held on August 15, 2013.

### **Discussion** Items:

**Frog Follies**: There are enough volunteer workers for Frog Follies. ERTA volunteers will work on August 23 and 24, 2013.

<u>Review of Current Policies</u>: A committee consisting of Carol Koehler, Darla Olberding, Pat Eager, Betty Schmitt, and Sandra Schmidt will review ERTA policies.

Welcome Back Baskets: Baskets to welcome teachers back to a new school year will be delivered on August 12, 2013, by five teams of two ERTA members.

**<u>E-Newsletter</u>**: Besides going green, money will be saved by e-mailing the newsletter.

**Board Member Replacement:** Director Garland Aramowicz has resigned from the Board because she is working. Bob asked for recommendations to fill the vacancy. The vacancy will be filled at the next Board meeting.

### Luncheon Meeting

August 8, 2013

President Bob Suhrheinrich called the meeting to order at noon at American Baptist East Church. He welcomed everyone to the first of five meetings for the year and reported today's attendance of around 190. Bob asked members and guests to stand for the Pledge of Allegiance.

Chaplain Ed Rusk read "Authority without Wisdom Is Like a Heavy Axe with an Edge, Fitter to Bruise than Polish." Then, he read Proverbs 28:16 and prayed.

Bob introduced those seated at the head table: Ed and Ruby Rusk, EVSC Executive Director of Development Gail Long Kiesel, and EVSC Superintendent Dr. David Smith, today's program speaker.

### Announcements:

Bob acknowledged Phyllis Fitzgerald and Diana Luck for putting together the first ERTA E-Newsletter. He then reviewed the following key points in the newsletter: membership information on ERTA and IRTA, the importance of volunteer hours, the stipend from the state that is added to the September check, the names of members who have passed, and information about volunteering to work at Frog Follies.

Candy-filled baskets from ERTA will be delivered to all EVSC schools on August 12, 2013, to welcome teachers back to the classroom.

Marion Reisinger's name was omitted from the UE/USI Scholarship Committee. She will continue to chair that committee.

Bob said that there is an information sheet explaining the first "Annual Campaign for EVSC Schools" as well as other items on the information table.

Before dismissing members and guests for meal service, Bob introduced Irene Saucer and her guest Dr. Carol Hawkins, an instructor at Miami Dade College.

As members finished eating, Bob thanked Ed and Ruby Rusk, Ella Shelton, and Susan Mosbey for setting the tables and serving drinks. He also thanked Jane Whitehouse for handling the table decorations. Attendees were then asked to move to the sanctuary for the program.

### Program:

Bob introduced Dr. Smith by telling about the time they worked together. Using a power point presentation entitled "What We Believe," Dr. Smith spoke about EVSC's "Continuous Improvement Process" with the ultimate goal of having every student on grade level and on track for college or a career. He listed three priorities of the school corporation to help students achieve this goal. Also, Dr. Smith briefly discussed financial constraints for the corporation due to

decreasing revenue and rising costs. He said that the School Board has no discretion in the budget any longer. The "Annual Campaign for EVSC Schools" will give principals some discretionary funding needed to help students and staff. Dr. Smith finished by opening the floor for questions. A number of members asked questions. Bob presented Dr. Smith with a gift card.

May Luncheon Meeting Minutes: The May 9, 2013 Minutes were approved as printed in the August newsletter.

**October's Luncheon Speaker**: Bob announced that Derrick Stewart, the CEO of the YMCA, will be our speaker at the October 10, 2013 meeting.

# IRTA Scholarship Update

Up until this year, the Indiana Retired Teachers Association awarded scholarships under the guidance of the IRTA Scholarship Committee. This year, the scholarship fund has been moved to the IRTA Foundation and will no longer be under the direct control of the scholarship committee. The IRTA Scholarship Committee will no longer exit as a standalone committee but will serve as an entity of the foundation in order to determine scholarship winners. Our very own Sylvia Blice is a member of this committee. Why is this important to you? Essentially there are no differences other than a concerted effort by IRTA to consolidate fundraising and the ability to sustain scholarship opportunities for college students in the future.

About the scholarship itself:

- one scholarship awarded yearly to a student from each of the nine areas of the state (\$3,000 this past year)
- applicant must be a direct descendent or legal dependent of an Indiana teacher (teacher can be active, retired or deceased)
- applicant must be enrolled in an education program at an Indiana college or university
- applicant can apply as either a sophomore or junior
- applicant must have at least a "C" average GPA in the first three semesters of his college work

Please do not confuse the IRTA scholarship with our very own ERTA scholarship. Each year ERTA awards scholarships to a University of Evansville student and a University of Southern Indiana student. Both of these selections are education majors.

Poems are made by fools like me. But only God can make a tree.


